Being an Act to conclusively fix the dates on which several specified Bougainville laws are taken to have commenced, and for related purposes

MADE by the House of Representatives

1 Short title

This is the *Laws Validation Act 2014*.

2 Validation of *Interpretation Act 2005*

The *Interpretation Act 2005* is taken to have commenced on 21 December 2005.

3 Validation of *Tax Administration Act 2006*

- (1) The *Tax Administration Act 2006* is taken to have commenced on 29 March 2006.
- (2) Anything done or omitted to be done before the commencement of this section under any provision of the *Tax Administration Act 2006* is taken to have been valid.

4 Validation of *Council of Elders (Head Tax) (Enabling) Act 2006*

- (1) The *Council of Elders (Head Tax) (Enabling) Act 2006* is taken to have commenced on 27 June 2006.
- (2) Anything done or omitted to be done before the commencement of this section under any provision of the *Council of Elders (Head Tax) (Enabling) Act 2006* is taken to have been valid.

5 Validation of *Official Personal Staff Act 2008*

The *Official Personal Staff Act 2008* is taken to have commenced on 13 May 2008.

6 Validation of *Bougainville Education Act 2013*


The *Bougainville Education Act 2013* is taken to have commenced on 15 May 2014.


